A mild “sun-burn” sensation may follow for typically up to one hour and will be reduced with application of cooling and soothing creams Reddening and swelling – severity and duration depend on the intensity of the treatment and the sensitivity of the area to be treated. These phenomena may be reduced with application of cooling and/or anti-inflammatory creams Bruising may rarely occur and may last up to 2 weeks
